A new home for girls

After much difficulty and a long wait, we received permission to construct our new home for girls on August 28, 2019. It broke our hearts to turn vulnerable children away for lack of infrastructure, but now we are delighted that this dream is coming true and we will soon be able to accommodate 100 more children that we do today. NS Hema Award

We won the prestigious N S Hema Award in October 2019 [instituted by the Association of People with Disability (APDI)], for being an "Outstanding NGO in Disability". In the past years, the awards call was restricted to Karnataka but was opened up for the first time in 2019 to five South Indian states and union territories. The award is a tribute to disability activist N S Hema, remembering her mission started half a century ago.

COVID 19 Outreach

No one ever anticipated a crisis like COVID-19. Our outreach began by stitching and freely distributing cloth masks to vulnerable sections of society but soon progressed to feeding migrants, distributing dry rations to poor families, and working with sponsors to provide monthly stipends to families with disabled children who went broke and struggled to survive under the lockdowns. VAISHNAVI

Age at admission 2 **Current age 3**

Born to a 54 year old woman with mental health issues, Vaishnavi was kept under lock and key since birth. Rescued and transferred to the Egmore Baby Hospital in Chennai, she was diagnosed with severe malnutrition, weighing a mere 4 kilos.

She came to us in January 2020, still a little weak and crying a lot. She couldn't even sit up. But, "a healthy child is a happy child" and that proved true as she grew strong on a nutritious diet. Mobile and vivacious today, she's a happy little explorer. Vaishnavi receives the undivided attention of a special educator through our Individualized Education Program (IEP).

About Sri Arunodayam

For over 18 years, Sri Arunodayam has been providing a safe and caring environment for abandoned children with intellectual disabilities through its homes at Chennai, India. These children have been abandoned in hospitals and crowded public places such as railway and bus stations. At times, even in dustbins! At our home they are welcomed, nurtured, rehabilitated and loved. We try to give them what they have lost - a home and a family!

NURTURE - Abandoned and fearful, children arriving at our home need medical care. They are nurtured and comforted, and when ready to interact, are moved to the next phase of rehabilitation.


REHABILITATE - Children are assessed are placed in Early Intervention, Pre-Primary and Primary or Vocational programs, according to their abilities. They are encouraged to attain goals at their own pace. Youngsters above the age of 18 are provided skills training through Prayatna - our vocational training center.

RESTORE - Every attempt is made to trace a child's family. Parents who abandoned their children on account of poverty, but are willing to be reunited are provided counsel. Our legal department has reunited 93 children with their families, till date.

Hardly a few months old when her mother died, Nithya was surrendered to an orphanage by her father as she has a mild form of intellectual disability. The journey from home to home had upset her and she was considered a "problematic" teenager when we received her three years ago. Too old to study and too young to work, she fit well into Prayatna, our vocational training center where she developed unique skills. Her penchant for troublemaking soon disappeared and she blossomed into a caring young lady.

Loving our children helps them love themselves and others, and as Nithya learns to love herself, she's becoming an inspiration to others, making her own unique mark in the world today.



HOME FOR GIRLS

A legacy in the making, our new home for abandoned little girls with intellectual disabilities is coming to life with each passing day!



Started in August 2019, this project is truly a work of grace! We had been preparing for it back in 2017 but had a difficult time getting approvals from local authorities. Through sheer determination and (loads of) patience, the project took off.

We call it a "work of grace" because six short months into construction, the pandemic struck and not only brought construction to a halt, but also disrupted donor pledges.

Yet, rising like a phoenix, the project resumed in May 2020! Today, we are almost done with the roof of the second and final floor. By the end of 2021 this new

"residential-cum-rehabilitation" home will house an additional 100 more abandoned children than we do today.

Faced with our own mortality like never before, we have a golden opportunity to leave a lasting legacy to protect

society's most vulnerable citizens, by building this home. Come, join us in this work of grace!

Abandoned on a deserted road, Sumangali was picked up and sent to us in March 2010. Her severely impaired condition due to spastic cerebral palsy made survival a grim possibility. Medical care and a healthy diet set her on the road to recovery. Physiotherapy, individualized special education (IEP) and speech therapy followed. She is independent today, helping care for other little ones. The right therapies and a little love is all it took to give her a fighting chance at life!
