A new report by the World Health Organisation (WHO) released end-2022 shows that the number of people with significant disabilities worldwide has risen to 1.3 billion, or one in six people. You read right – one in six! In effect, we need to gear up to assist this growing population ourselves or start creating an environment that helps them help themselves!

One of the first steps in improving the participation and quality of life of people with disabilities is to recognize how their environment impacts their experience of disability. Without the right aid/equipment, support in educational/workplace settings, mainstream education, accessible public transport, or personal assistance, they will have no opportunity to participate in the economic and social world. An environment that discourages their participation is a barrier to their achieving independence.

Mahatma Gandhi said, "The true measure of any society can be found in how it treats its most vulnerable members". This will be the litmus test for Governments. Their greatness will not be measured by GDP or voluminous infrastructure projects but rather by their efficiency in establishing systems that encourage equal participation and high quality of life for their citizens, able-bodied or not.

In January 2023, we commenced building our aftercare-cum-rehabilitation home for young adults with intellectual disabilities. We incorporated the principles of accessibility into our architectural plan right from inception because true accessibility is not an afterthought. When included right from the drawing board, it encourages participation and a celebration of life!

### **DEVELOPING CHARACTER THROUGH SPORTS**

Sri Arunodayam consistently grooms its children in the area of sports which offers health benefits beyond physical fitness. The children learn sportsmanship which is about respect and fair play, essentials for social integration and emotional growth. We continue to honor mothers of children with special needs through our annual awards. <u>Twenty awardees were selected for 2022|23</u> from more than 100 applicants, for their progressive abilities and for making a significant impact in the lives of their children, families, and communities. ## Sunithi

## **AGE 17**

To eradicate female infanticide and to save the girl child from the clutches of death, the "Cradle Baby Scheme" was first introduced in Salem District, Tamil Nadu in 1992. Sunithi was rescued through this scheme. The fourth daughter of a poor couple from Krishnagiri Taluk in Tamil Nadu, Sunithi was abandoned as her parents could not provide for her specialized healthcare (she is hyper active and lives with intellectual disabilities).

Being hyper active, it was a task getting her to listen. Our special education program for the hyper active introduced a series of corrective techniques, including routines to provide structure and stability, indoor and outdoor games, relaxation techniques such as deep breathing, progressive muscle relaxation, visualization and yoga, and task completion exercises. She is doing well in the classroom now, learning to read, color, trace, write, and build with building blocks. Finding what works for Sunithi as a unique individual is the crux of our program that has proven to be very effective in overcoming hyperactivity. She's a lot more focussed and like a little sunbeam – bright and cheerful!






Another "Cradle Baby" ", Pooja, was welcomed into our home. Abandoned by her economically poor parents at Dharmapuri District, Tamil Nadu, Pooja was placed in an adoption agency. She was adopted by a couple but returned to the agency when they found she is intellectually disabled. She was later sent to us.

Pooja is fifteen years old and lives with cerebral palsy. She was immobile and in a lot of pain when she came to us. Our trained professionals are setting her right through a customized program that includes good nutrition and daily physiotherapy.

Our program for cerebral palsy encourages Pooja's progress through behavioral therapy, occupational and speech therapy, the use of assistive devices to increase independence, and direct communication with eye contact. Pooja is a quick learner and has learnt to write and color with crayons, which is her favorite activity. She continues to progress and we believe she will soon overcome her difficulties.





# Building an aftercare ecosystem that celebrates life!

For the intellectually disabled in childcare homes, turning 18 is a nightmare! Thousands of vulnerable youngsters are struggling to rebuild their lives after leaving a childcare institution because the law stipulates that they must, when they reach the age of 18. But what about youngsters with intellectual disabilities (ID)? They are children locked in an adult body! Having had a late start in life, they aren't able to fend for themselves by 18. They qualify for "aftercare" – something that very few childcare homes in India offer.

Sri Arunodayam is one of these few institutions given permission to build an "aftercare-cum-rehabilitation" facility for such youngsters. The project commenced in January 2023 in Tiruttani. This inclusive, disabled-friendly aftercare ecosystem includes an administrative command center, a fully furnished aftercare-cum-rehabilitation home for around 100 youngsters, a physiotherapy center, a vocational training center, a medical center, dormitories, restrooms, centralized kitchen, pantry, dining halls, an amphitheatre, beautiful flower gardens, orchards, and more! Our dairy farming and agricultural projects will be run from here.

Sri Arunodayam will also open its doors to children with ID from surrounding communities, giving them free education through a Special School being built on this campus.

In short, Sri Arunodayam's "aftercare ecosystem" is not planned for its youngsters alone but to sustainably embrace and build up the local community in which it operates.

Praveen was just a baby when his parents abandoned him at Coimbatore in May 2008. He was only three years old when he came to us. Praveen lives with intellectual disabilities and cerebral palsy. A bowed femur and tibia on his right side obstructed mobility and he could only crawl for a very long time. A nutritious diet set many things right along with working with his physiotherapist almost daily.

Praveen's flexibility and range of motion (ROM) has improved. He receives electrical stimulation therapy to help ease muscle spasms and pain. Today, he's able to stand, use the therapy ball and walk with the help of a walker. Praveen is a determined child and we know that he'll make it one day soon!
